This is a synchronous online class that meets at the designated time just like regular class. I expect attendance in class as the interaction and the chat features during the designated times of the class will be helpful for your learning.

Exams and quizzes will be through canvas. You will need a camera on your computer to take the exams and quizzes.

Financial statements are a key source of information about the economic activities of a firm. This course addresses the construction and interpretation of financial statements. The goal of the course is **NOT** to train you to become an accountant. Rather, the course should equip you to become an informed user of financial statement information. Because annual reports are somewhat formidable, we will study how firms present the information for various accounts in their financial statements, including the footnotes. By the end of the course, you should have a basic understanding of financial statements and the ability to use this understanding to analyze business situations and recommend appropriate actions (MBA learning goal "critical thinking"). Furthermore, we will discuss the subjective nature of accounting choices which will enable you to identify ethical dilemmas in the context of financial information and allow you to recognize and evaluate alternative courses of action (MBA learning goal "ethical reasoning").

Several features of the course facilitate achieving the course objectives. The textbook provides a conceptual foundation for the course by introducing the accounting framework and by characterizing accounting principles and alternative methods. The online videos and practice problems will help you learn the more technical aspects of accounting. I also assign several articles from the financial press. These articles will help you to gain further understanding of real-world financial reporting issues. The cases serve as the basis of class discussion and provide a challenging test of your understanding of the topic. They are designed to help illustrate the issues associated with various accounting methods and the manner in which the information is disclosed in corporate financial statements. After graduation, many students report that this course is one of the most valuable courses during their time as an MBA student. My hope is that you will be one of these students.

COURSE INFORMATION

The course is organized in Canvas around weekly modules. Each module includes a series of instructional videos, practice problems and quizzes. The due dates for all assignments and quizzes will be clearly posted in each module.

I will also hold weekly Zoom meetings during scheduled class hours. This will be a time for me to go over some key PowerPoint slides and to discuss cases and answer questions. I will also be available for virtual office hours using Zoom by appointment.

Each of you will be assigned to a team for group case assignments. During our first Zoom meeting, I will discuss how these groups will function.

Final grades will be based on a university approved grading scale: A = 90 or above, B + = 86 to 89.9, B = 83 to 85.9, B - = 80 to 82.9, C + = 76 to 79.9, C = 73 to 75.9, C - = 70 to 72.9 F = below 59.

Although not specifically identified in the calculation of grades, attendance and active participation are expected of all students. A grade of "C" or better is required to pass this class.

Attendance and active participation are expected of all students even though we have our class meeting virtually.

There will be multiple short, online quizzes throughout the semester. There will be 9 such quizzes and account for 30% of your final grade. Cases

Three cases are to be completed in group teams and submitted on Canvas. We will discuss teams during the first classroom meeting. All other cases are chosen to stimulate, rather than solidify your thinking and facilitate meaningful class discussions. The cases discussions are an integral part of the learning experience of the course. I expect that you will prepare the cases and assignments for each class in advance and that you will be actively involved in all discussions during our class time, including asking questions and sharing your knowledge and experiences with the rest of the class. In some situations, the readings and cases may represent your first exposure to a particular issue or problem; in such instances, you are expected to read and work through the questions to the best of your ability or your team's ability. It is likely that you will not understand or be familiar with all terms that are used in the readings, cases and assignments. The responsibility for increasing your understanding of these terms lies jointly with you (to look up these terms and phrases prior to class) and me (to lay out the fundamental issues in class as part of the lecture and discussion).

Class Participation

I always expect professional conduct in the classroom. Each student is expected to be prepared and actively involved in all class discussions, including asking questions and sharing your knowledge and experiences with the rest of the class. I will call on students that volunteer to participate but will avoid calling on the same students repeatedly. Reward is not given solely for the quantity of comments. Furthermore, there are no

penalties for "wrong" answers. It is the attempt to thoughtfully reason through a problem or to ask a pertinent question that is valued and adds to the classroom experience for everyone. Cold calls are fair game.
