Course Description

I want you to be "rock star" information systems professionals—the "go to" person in your group; the person that understands what is going on, and how to get from the current state to a desired end state; the person your clients, coworkers, and boss trust...and eventually you'll be the boss. I want you to get the job you want and to have a great career.

In order to achieve this, you must understand many aspects of information systems – from the managerial and political, to the deeply technical. You must understand how these different aspects interact with one another, and be able to explain/discuss these things in a meaningful way.

This is how Management Information Systems differs from more technical pursuits (such as computer science or engineering) and strictly business-oriented pursuits (such as general management, marketing, or accounting)—MIS professionals understand the technical aspects, the business aspects, AND how the technical and business interact. The goal of this class is to develop these connections.

Learning Objectives

Each chapter will have specific learning objectives to help you gauge your understanding of the material (and ensure you are prepared for the exams!), but overall, by the end of this class you should be able to describe:

- What are contemporary information systems, and how are they being used in innovative ways?
- Why are information systems so important and interesting?
- How best can we build, acquire, manage, and safeguard information systems?
