COURSE FORMAT

This course is taught *asynchronously*, which means there is no designated day or time assigned to the course (although optional synchronous sessions are possible, such as virtual office hours or guest lectures). Asynchronous instruction involves accessing content, such as recorded video lectures, readings, assignments, and assessments during a flexible time frame, with due dates as specified on the last page of this syllabus.

COURSE OVERVIEW

A major factor of your future career success in an increasingly global business environment is your ability to relate to and work with people from different cultures. Cultural intelligence (CQ) refers to one's ability to adapt to environments that are different from the ones in which they were socialized. CQ is important because culturally intelligent managers make better decisions in cross-cultural contexts, they are better at communicating across cultures and they can help bridge cultural divides in an organization.

We will tackle the following learning objectives, with the goal of expanding your cultural intelligence:

- 1. Understand the importance of cross-cultural awareness
- 2. Analyze various cross-cultural frameworks
 - o Hall's cross-cultural framework
 - o Hofstede's cross-cultural framework
 - o Trompenaars and Hampden-Turner's cross-cultural framework
- 3. Apply cross-cultural frameworks to specific situations with the goal of developing *cultural metacognition*, the ability to interpret cultural ques and respond to them effectively

INTRODUCTION

The first assignment in this class is to create an introduction post. **Make sure to complete this assignment before reading any of the other course content!** Go to Microsoft Teams, *Introductions channel*, and answer the discussion prompt. Your introductions are due by December 22nd at 11.59pm. Late posts are penalized 10 points per calendar day.

SELF-ASSESSMENT

You are required to complete a self-assesment based on Hall's cultural framework and then write a self-reflective analysis. This assignment is posted on Microsoft Teams, <u>under Assignments</u>. It is worth 40 points and it is due on December 22nd at 11.59pm. Late submissions are penalized 10 points per calendar day.

TEAM DISCUSSION

Week 2 - Hofstede channel on Microsoft Teams contains instructions on completing your Team Discussion. You are required to meet with your assigned classmates and answer the discussion prompt. This assignment is worth 40 points and it is due by December 29th at 11.59pm. Late submissions are penalized 10 points per calendar day.

COUNTRY ANALYSIS

Each student is required to select a country of interest and create a new channel for that country. You will be the owner of that channel and responsible for creating your own content. The goal of this assignment is to create an online training manual for someone going on a work assignment to the country that you selected. Specific instructions on how to create channel content and the type of content that must be included on your channel are posted on Microsoft Teams, *Week 2 - Hofstede* channel, under Country Analysis Instructions. You must finalize your channel content by January 6th at 11.59pm.

EXAMS

There are two exams in this course and these are the only two assignments that will be taken through Canvas (not Microsoft Teams). Each exam is worth 60 points and it consists of a combination of multiple choice and true/false questions. Please note that exams are only available during a specific week. Exams are timed and you have one attempt at each exam. Exam 1 is available December 24th - December 29th at 11.59pm and it covers readings/videos on Hofstede (study material can be found on channel titled *Week 2 – Hofstede*) while Exam 2 is available January 1st - January 5th at 11.59pm and it covers readings/videos on Trompenaars (study material can be found on channel titled *Week 3 – Trompenaars*). Late exam submissions are penalized 10 points per calendar day.

CASE ANALYSIS

The case analysis is based on the case from the Harvard Business publishing coursepack. After you read the case, go to Microsoft Teams Assignments to read the instructions. Your analysis is due by January 10th at 11.59pm. Late submissions are penalized 10 points per calendar day.
